KNOW ALL MEN BY THESE PRESENTS:

THIS CONTRACT/AGREEMENT, made and entered into this 02 JAN 2024 day of January, 2024 in Butuan City, Philippines, by and between:

DENR-Provincial of Environment and Natural Resources, with an office address at Brgy. Tiniwisan, Butuan City represented by OIC Provincial Environment and Natural Resources Officer, Joseph Leo E. Oconer, RFP hereinafter called the ENTITY;

- AND -

SHERLOCK SECURITY AGENCY represented by its Proprietor Manager, MR. RICKY C. TABASA with office address at 2ND Floor, Eduhome Bldg., A.D. Curato St., Butuan City, hereinafter called the SUPPLIER.

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly for the Procurement of Security Services for DENR-Provincial Environment and Natural Resources- Agusan del Norte. To wit:

- a. One (1) Security guard 12 hours daily duty from 6:00PM to 6:00AM including Saturdays, Sundays and Holidays and one (1) Security guard to render a 12 hours duty from 6:00AM to 6:00PM during Saturdays and Sundays only for PENRO, Agusan del Norte;
- b. For CENRO- Nasipit, Agusan del Norte: Two (2) security guards to render in a two (2) shifting schedule for twelve (12) hours daily including Saturdays, Sundays and Holidays. One (1) guard to render his service from 6:00AM to 6:00PM and One (1) guard to render his service from 6:00PM to 6:00AM. and
- c. For CENRO- Tubay Agusan del Norte: Two (2) security guards to render in a two (2) shifting schedule for twelve (12) hours daily including Saturdays, Sundays and Holidays. One (1) guard to render his service from 6:00AM to 6:00PM and One (1) guard to render his service from 6:00PM to 6:00AM.

WHEREAS, the ENTITY has accepted a Bid by the Supplier for the supply of those services in the sum of ONE MILLION THREE HUNDRED THIRTY THOUSAND ONE HUNDRED FIFTY FOUR PESOS AND 80/100 (P1,330,154.80) ONLY as the Contract Price.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Contract Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The delivery of service shall commence on February 1, 2024 until January 31, 2025.
