- 4. Price quotation/s, to be dominated in Philippine Pesos shall include all taxes, duties and/or levies payable.
- 5. Price quotations exceeding the Approved Budget for the Contract shall be rejected.
- 6. Award of Contract shall be made to the lowest calculated and responsive offer which complies with the minimum technical specifications and other terms and conditions stated herein.

# CATERING SERVICES FOR THE CENRO-TUBAY YEAR-END ASSESSMENT CUM NGP PERFORMANCE EVALUATION FOR CY 2024

#### I. BACKGROUND

CENRO Tubay has numerous targets in both Technical and Management Services based on the approved Work and Financial Plan (WFP) of CY 2024.

As such, year-end assessment is deemed necessary to assess the status and timeliness of each unit's accomplishments including the over-all performance of the eNGP. Likewise, validate the corresponding means of verification (MOVs) and review funds disbursement in accordance to the reported accomplishment.

#### II. OBJECTIVES

- a. Presentation of accomplishments per sector;

- E. Provision of tablecloth, tableware and complete cutlery. Tablecloths must be presentable and well-ironed. Buffet table must be covered with full-skirting. Table lay-out will be provided by the caterer.
- F. Free flowing purified water starting 11:00 in the morning to 8:30 in the evening.
- G. Foods and drinks to be served will be available before 12 noon.
- H. Provider should strictly follow the necessary health and safety measures (e.g., use of gloves, hair net, face masks, alcohol, and frequent washing of hands, etc.) to ensure the quality, safety and timeliness of the food and avoid health hazards.
- The provider is discouraged to use "single-use plastic" for drinks and food container.
