

1. Service Providers shall provide correct and accurate information required in this form
2. Service Providers may quote for any or all items, unless otherwise stated.
3. Price quotation/s must be valid for a period of sixty (60) calendar days from the closing date.
4. Price quotation/s, to be dominated in Philippine Pesos shall include all taxes, duties and/or levies payable.
5. Price quotations exceeding the Approved Budget for the Contract shall be rejected.
6. Award of Contract shall be made to the lowest calculated and responsive offer which complies with the minimum technical specifications and other terms and conditions stated herein.
7. Any interlineations, erasures or overwriting shall be valid only if they are initialed by the authorized representative of the Service
8. The item/s and/or services shall be delivered according to the requirements specified herein/attached Terms of Reference.
9. The DENR shall have the right to review/examine submissions relative to the project to confirm conformity to the project requirements
10. Payment shall be made in accordance with the Terms of Conditions of the Contract.
11. Liquidated damages equivalent to one tenth of one percent (0.1%) of the value of contract not delivered within the prescribed completion period shall be imposed per day of delay. The DENR may rescind the Contract once the cumulative amount of liquidated damages reaches ten percent (10%) of the amount of the Contract, without prejudice to other courses of action and remedies open to it

TERMS OF REFERENCE (TOR)
CONSTRUCTION OF CONCRETE PERIMETER FENCE
FOR CENRO NASIPIT DEPOSITORY AREA

I. ABSTRACT

Title of the Project : **CONSTRUCTION OF CONCRETE PERIMETER FENCE FOR CENRO NASIPIT REGIONAL DEPOSITORY AREA**

Approved Budget for the Contract (ABC) : **₱ 980,000.00**

Project Period : **45 Calendar Days**

II. BACKGROUND

An approximately 120 meters of concrete perimeter fence within the property of CENRO Nasipit Regional Depository area adjacent to Gothong Cargo collapsed due to overnight heavy downpour of rain and the concrete weakened due to the corrosive effects of salt on the steel reinforcement that formed rust on the rebar, which expands and cracks the concrete that leads to further degradation over time.

The reconstruction of the concrete perimeter fence is necessary to safeguard the deposited conveyances and other equipment to avoid losses and pilferage.

III. PROJECT OBJECTIVES

To construct a durable and secure concrete perimeter fence for the Regional Depository Area located at CENRO Nasipit, Talisay, Nasipit, Agusan del Norte within the allocated budget and timeline.

IV. SCOPE OF WORK

The contractor shall:

1. Conduct a site inspection to assess the project area.
2. Construct a concrete perimeter fence with the following specifications:
 - Length: 120 meters
 - Height: 2.50 meters
 - Materials: High-quality cement, reinforced steel bars, and other necessary construction materials.
 - Finishing: Smooth plastering.
3. Secure clearances, permits and other required requisite clearances for the construction.
4. Complete the project on or before the agreed duration of the project.
5. Ensure compliance with engineering and safety standards.

V. MINIMUM REQUIREMENTS FOR BIDDERS

1. Must be a duly licensed contractor.
2. Must have a valid PhilGEPS registration.
3. Must submit a detailed cost estimate, work plan and construction schedule.

VI. DELIVERABLES

The contractor must deliver the following within the project period:

1. Construction of the concrete perimeter fence as per the approved specifications.
2. Final inspection and turnover of the completed project.
3. Submission of a warranty certificate for workmanship and materials, valid for at least one (1) year.

VII. APPROVED BUDGET FOR THE CONTRACT (ABC)

The total approved budget allocated for this project is ₱980,000.00, inclusive of all applicable taxes and fees, labor, and materials.

VIII. PROJECT DURATION

The project must be completed within 45 calendar days from the issuance of the Notice to Proceed (NTP).

IX. CONTRACTOR'S RESPONSIBILITIES

The contractor is responsible for the following:

1. Providing skilled labor, equipment and necessary materials for the completion of the project.
2. Overseeing daily operations of the project site and managing all aspects of construction work.
3. Ensuring proper waste disposal of removed materials.
4. Addressing any defects or issues during the warranty period.

X. PAYMENT TERMS

Payment will be made upon satisfactory completion of the project, subject to the submission of the following:

1. 15% Mobilization, 85% based on the submitted accomplishment upon inspection.
2. Inspection report from the Project Engineer or authorized DENR personnel.
3. Invoice and supporting documents.

XI. PERFORMANCE SECURITY AND WARRANTY

The contractor must provide a performance security equivalent to 10% of the contract price, which will be held until the project is completed satisfactorily. Additionally, a warranty period of three (3) months will apply for any defects in materials or workmanship.

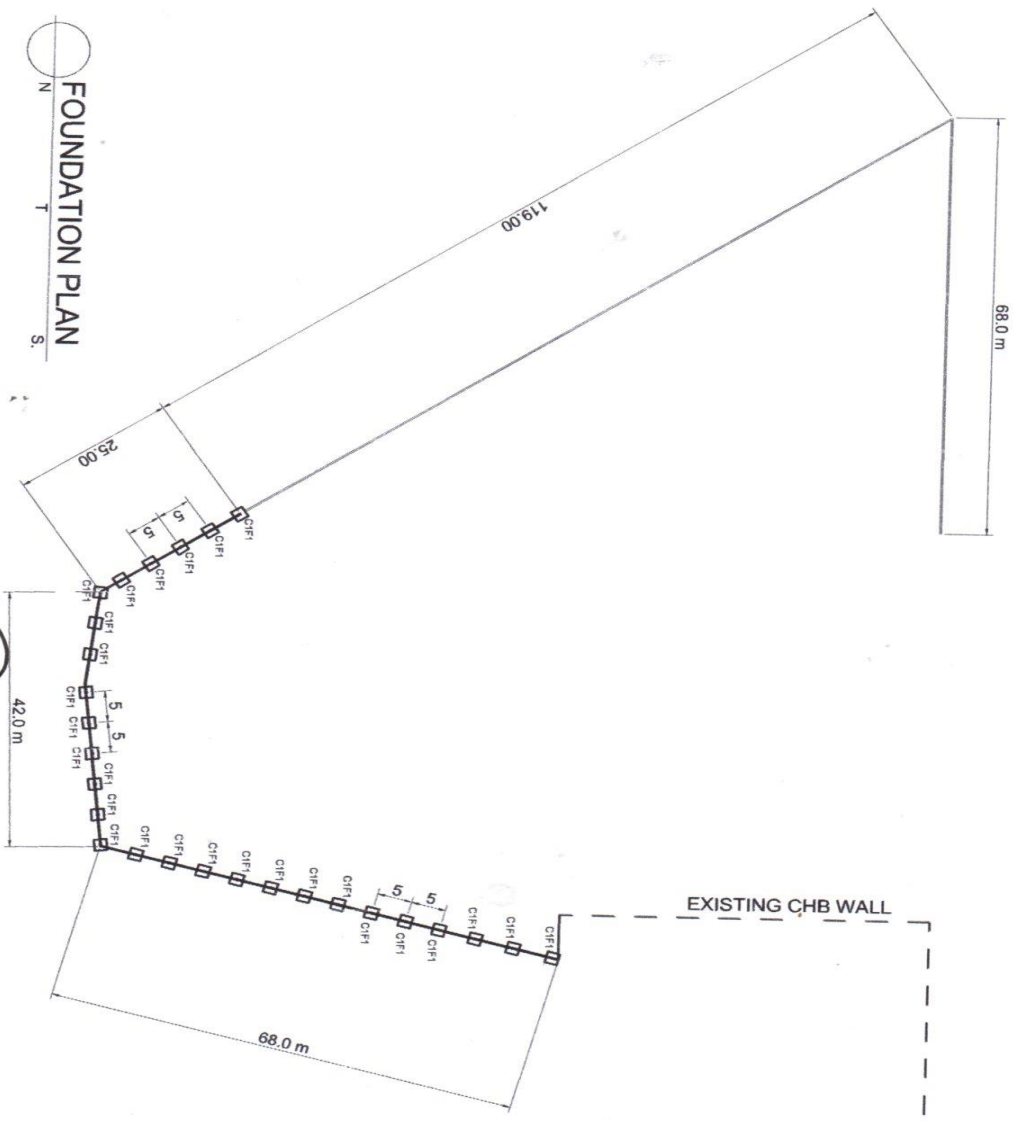
