- 5. Price quotations exceeding the Approved Budget for the Contract shall be rejected.
- 6. Award of Contract shall be made to the lowest calculated and responsive offer which complies with the minimum technical specifications and
- 7. Any interlineations, erasures or overwriting shall be valid only if they are initialed by the authorized representative of the Service Provider

III. DELIVERY PERIOD

The supplier shall deliver the items within thirty (30) calendar days upon receipt of Notice to Proceed (NTP).

IV. WARRANTY AND RETENTION

 The supplier warrants that the units supplied under contract are new, unused, of the most or current model based on the approved technical specifications.

- The supplier further warrants that the units supplied under this contract shall be free from defects.
- 3. Warranty is at least one (1) year on parts and services upon receipt of units.
- 4. This office shall promptly notify the supplier in writing of any claims arising under this warranty (Notice of Defects). Upon receipt of such notice, the supplier shall, within the period of ten (10) calendar days and with all reasonable speed, repair or replace of the defective goods or parts thereof, without cost to this office.

V. OTHER REQUIREMENTS

- The supplier shall ensure that the unit delivered is in accordance with the specification as required by DENR PENRO Agusan del Norte. This office has the right to reject delivery if units delivered were found to be defective and not according to the required specifications.
- 2. This office may terminated/cancel the Purchase Order (PO) when the supplier fails to deliver, perform, and comply with its obligation.

VI. PAYMENT TERMS

- Payment will be made upon satisfactory completion of delivery subject to complete documents for payment.
- 2. For every day of delay, 1/10 of 1% (0.001) of the price of undelivered quantity shall be deducted from the payment, in case the supplier fails to deliver the unit on time. Once the cumulative amount of liquidated damages reaches ten percent (10%) of the amount of the PO, DENR PENRO Agusan del Norte may rescind or terminate the contract, without prejudice to other courses of action and remedies to open it.
