- 5. Price quotations exceeding the Approved Budget for the Contract shall be rejected.
- 6. Award of Contract shall be made to the lowest calculated and responsive offer which complies with the minimum technical specifications and other terms and conditions stated herein.

#### II. BACKGROUND

The DENR recognizes forest fires are becoming more frequent and intense worldwide, leading to severe environmental, economic, and social impacts. Each year, millions of acres of forest are lost, threatening wildlife, endangering human lives, and destroying property. Factors like climate change and human activities are driving this alarming trend, highlighting the critical need for strategies to prevent and manage as well as suppression of forest fires effectively.

Understanding the complex impacts of forest fires is essential for safeguarding our natural landscapes and protecting the lives and homes of those in affected areas, thus the DENR-PENRO ADN's organization ensures to keep abreast with the much-needed fire-fighting equipment.

#### III. PROJECT OBJECTIVE

The main objective of the procurement of six (6) units of fire-fighting equipment is to enhance the capability of PENRO-ADN Enforcement Sections of PENRO Office and CENROs Nasipit and Tubay to address/respond to this threat, should this will happen by providing a fire-fighting equipment to ensure the safety of the fire fighters in fire responses.

#### IV. SCOPE OF WORK

This project will be procured through "competitive bidding" under the category of Menu 1. Full Logistics & material support essential in forest law enforcement. This method of procurement is open to participation by any interested party and which consists of the following processes: advertisement, pre-bid conference, receipt and opening of bids, evaluation of bids, post-qualification, and award of contract.

#### VI. DURATION OF ENGAGEMENT

Delivery of services (procured items) is expected to be completed within forty-five (45) calendar days from the date the Contractor received the formal Notice to Proceed.

## VII. SCHEDULE OF PAYMENTS

Payment of the items delivered shall be within thirty (30) days after receipt of the deliveries.

#### VIII. APPROVED BUDGET

The approved budget for the procurement of ICT equipment is the following:

1.) 6 sets of fire-fighting equipment - Php 660,210.00

This budget is inclusive of assembly services, delivery, incidental expenses, VAT and other government fees.

## IX. DELIVERY

Three (3) working days prior to delivery, the winning bidder must inform the PENR Officer in writing of the schedule of delivery so it can notify the PENRO Inspection Team.

The representative from the Property Unit shall accept delivery until 5:00 PM only, Monday to Friday.

If the winning bidder fails to satisfactorily deliver any or all of the goods/items and/or to perform within the period specified in the contract, inclusive of duly granted extension time, if any, the Procuring Entity shall without prejudice to its remedies under the contract and the applicable laws, deduct from the Contract Price, as liquidated damages, the applicable rate of one-tenth (1/10) of one percent (1%) of the cost of the undelivered and/or unperformed portion of everyday of delay until the actual and complete delivery of the goods/items.

The maximum deduction shall be ten percent (10%) of the amount of the Contract. Once the maximum is reached, the Procuring Entity shall rescind the Contract, without prejudice to other courses of action and remedies open to it.

#### X. ASSEMBLY, TESTING, AND ACCEPTANCE

The winning bidder shall deliver assembled items and test the Fire-Fighting equipment to determine its functionalities, benefits, and compliance to the standard specifications. This must be done in the presence of PENRO Inspection Team in the presence of COA representative before the final acceptance of the items.

#### XI. DOCUMENTATION

On the day of the delivery, the winning bidder must provide Warranty Certificate covering the Fire-Fighting equipment delivered.


